ITASCA and PROFESSOR agree to the following:

- 1. ITASCA agrees to provide 10 (ten) web licenses of ITASCA SOFTWARE for each license of the same software purchased for PROFESSOR, with a maximum of 30 web licenses issued for each separate software.
- PROFESSOR agrees to acknowledge ITASCA and ITASCA SOFTWARE in any publication utilizing results obtained while using the software and PROFESSOR will sign the accompanying release agreement.
- 3. PROFESSOR must ensure that the software is used for educational purposes only and can only be accessed by students enrolled in their course or research program. Any other use of the software is forbidden. It is explicitly stated this software **cannot** be used for any consulting work done by the PROFESSOR or outside of UNIVERSITY.
- 4. PROFESSOR, as the recipient, assumes responsibility for the selection of the software to achieve the intended results and for installation, use and results obtained. ITASCA assumes no liability whatsoever with respect to any use of the software, or any damages or losses that may result from such use.
- 5. Neither PROFESSOR nor UNIVERSITY may copy, modify or transfer the software, in whole or in part. Furthermore, PROFESSOR and UNIVERSITY are responsible for preventing any unauthorized use of the software.
- 6. Neither PROFESSOR nor UNIVERSITY shall re-sell, sub-license, rent or lease this software.
- 7. ITASCA retains all rights to the software, and nothing in this agreement abridges these rights.
- 8. UNIVERSITY agrees to the terms and conditions of Itasca's End User License Agreement ("EULA"). The EULA can be found on Itasca's website at https://www.itascacg.com/end-user-license-agreement-eula
- 9. PROFESSOR will receive software manuals for the free licenses in electronic format. However, paper manuals, if available, can be purchased by UNIVERSITY for an additional charge. This charge is non-refundable, and the manuals become the property of UNIVERSITY.
- 10. IEP Teaching licenses will be set with expiration one year from Effective Date.
- 11. PROFESSOR will provide ITASCA an annual report including the number of students attending their course and details on how ITASCA SOFTWARE is being used.
- 12. Renewal: Upon receipt of the annual report, ITASCA will extend the lease for one additional year up to two times. ITASCA SOFTWARE will be renewed only if UNIVERSITY maintains the purchased software at the current release version.
- 13. The terms of this agreement shall be in effect for three years from Effective Date, after which a new agreement will be drawn up if PROFESSOR wishes to continue in the program.

If more than one software Teaching License Agreement is desired, a separate agreement must be completed for each software.
